What You Need to Know When Opening a Political Committee

- Every candidate must file paperwork with the Board of Elections office to organize a political committee within ten days of:
 - Receiving or spending any money in support of their candidacy,
 - Filing a Notice of Candidacy, or
 - Making a public announcement of a definite intent to run for public office in a particular election; whichever comes first.
- When you file the committee paperwork with the Board of Elections, you will receive a copy of the Campaign Finance Manual. Be sure to read it carefully.
- It is required that campaign funds be maintained in a bank account that is used exclusively by the political committee. **The use of personal bank accounts for campaign purposes is no longer permitted.**
- The candidate may appoint himself or any individual, with exception of the candidate's spouse, to serve as treasurer for the committee. Treasurers must participate in training as to the duties of office within three months of appointment. All treasurers must be trained regardless of the amount of money raised or spent during the election cycle. For more information on treasurer training, visit the State Board of Elections website at www.sboe.state.nc.us and select *Campaign Finance*, then *Training*.
- When deciding whether to file over or under the \$1,000 threshold, keep in mind that anything you purchase with personal funds for the campaign will count toward that \$1,000.
 - For example, if you decide to purchase political signs using personal money, the cost of those signs is considered a contribution to the committee.
- All committees should keep accurate records of contributions and expenditures regardless of whether the committee filed over or under the \$1,000 threshold. In the event that the threshold is exceeded, full disclosure of activity will be required.

The first campaign finance report a committee files is called the Organizational Report. This report must be postmarked within 10 days of either:

- (a) A public declaration of candidacy, or
- (b) The date of the committee's first contribution, or
- (c) The date of the committee's first expense, or
- (d) The date of the committee's first loan, or
- (e) The date of filing a Notice of Candidacy, or
- (f) The date of filing a Statement of Organization, **WHICHEVER OCCURS FIRST.**

Campaign finance reports include a series of forms, all of which are available on the State Board of Elections website. <http://www.sboe.state.nc.us>

All reports contain **AT LEAST** a Disclosure Report Cover (CRO-1000) and a Detailed Summary (CRO-1100). These two forms are attached. If the committee has not raised or spent any funds, then the summary page will contain cash-on-hand beginning and ending balances of \$0.

If the committee received contributions or made expenditures, additional pages need to be included in the report. If for example, a candidate loans his/her campaign money to open a bank account, a Loan Proceeds Form (CRO-1410) and a Loan Proceeds Statement (CRO-6100) would be needed or if a committee makes expenditures a Disbursements Form (CRO-1310) will be an additional page in the report.

Candidates for statewide, legislative and judicial offices file reports at the State Board of Elections.

Candidates for County and Municipal offices file reports at their County Board of Elections.

State and County campaign finance staff can advise new committees on the proper forms to include in a report.

163-278.7

Every treasurer of a political committee shall participate in training as to the duties of the office within three months of appointment and at least once every four years thereafter. The State Board of Elections shall provide the training as to the duties of the office in person, through regional seminars, and through interactive electronic means. The treasurer may designate an assistant treasurer to participate in the training, if one is named under subdivision (b)(8) of this section.

Effective October 1, 2006

§ 163-278.16B. Use of contributions for certain purposes.

(a) A candidate or candidate campaign committee may use contributions only for the following purposes:

- (1) Expenditures resulting from the campaign for public office by the candidate or candidate's campaign committee.
- (2) Expenditures resulting from holding public office.
- (3) Donations to an organization described in section 170(c) of the Internal Revenue Code of 1986 (26 U.S.C. § 170(c)), provided that the candidate or the candidate's spouse, children, parents, brothers, or sisters are not employed by the organization.
- (4) Contributions to a national, State, or district or county committee of a political party or a caucus of the political party.
- (5) Contributions to another candidate or candidate's campaign committee.
- (6) To return all or a portion of a contribution to the contributor.
- (7) Payment of any penalties against the candidate or candidate's campaign committee for violation of this Article imposed by a board of elections or a court of competent jurisdiction.
- (8) Payment to the Escheat Fund established by Chapter 116B of the General Statutes.
- (9) Legal expense donation not in excess of four thousand dollars (\$4,000) per calendar year to a legal expense fund established pursuant to Article 22M of Chapter 163 of the General Statutes.

(b) As used in this section, the term "candidate campaign committee" means the same as in G.S. 163-278.38Z(3).

(c) Contributions made to a candidate or candidate campaign committee do not become a part of the personal estate of the individual candidate. The candidate may file with the board a written designation of those funds that directs to which of the permitted uses in subsection (a) of this section those funds shall be paid in the event of the death or incapacity of the candidate. If the candidate fails to file the written designation before death, the personal representative of the estate may file the written designation within 90 days of the date of death, and may only direct those funds to donations under subdivision (a)(3) of this section. After the payment of permitted outstanding debts of the account, the candidate's filed written designation shall control. If the candidate files no such written designation, the funds after payment of permitted outstanding debts shall be distributed in accordance with subdivision (a)(8) of this section. DISTRIBUTING PRE-MARKED SAMPLE BALLOTS

GS 163-165.2(b)

Document Resembling an Official Ballot to Contain Disclaimer. – No person other than a board of elections shall produce or disseminate a document substantially resembling an official ballot unless the document contains on its face a prominent statement that the document was not produced by a board of elections and is not an official ballot.

In 2008, the State Board of Elections had the issue of the extent of the disclaimer referred to in GS 163-165.2 before it. The SBOE ruled that a disclaimer is sufficient if an average voter could easily determine that it was not an official ballot and where the ballot came from.

Sample Ballots and Campaign Finance Statutes

Sample ballots are considered print media and are therefore required to contain a legend (i.e. "Paid for by [Name of committee]"). If the sample ballot is marked for candidates other than yourself, it must also contain an authorization statement (i.e. "Authorized by [name of candidate], candidate for [name of office]" or "Not authorized by a candidate").

Brunswick County Sign Ordinance

10.7.4. Architectural Features of Buildings

Integral decorative or architectural features of buildings and works of art, so long as such features or works do not contain letters, trademarks, or moving parts.

10.7.5. On-Premises Instructional Signs

A. Description

On-premises instructional signs giving information or direction for the convenience and necessity of the public. See the Definition in Section 10.4 for further description.

B. Standards

Such signs shall not exceed six square feet in area or four feet in height. Any commercial message or logo contained in the sign shall not be legible from the public roadway or neighboring properties.

10.7.6. Identification Signs for Residential Uses

A. Description

On-premises instructional signs giving information or direction for the convenience and necessity of the public. See the Definition in Section 10.4 for further description.

B. Standards

When associated with a residential use, identification signs not to exceed four square feet on any lot. (See Section 10.8, Signs Requiring Permits, for signs associated with a commercial use or larger than four square feet in size).

* 10.7.7. Campaign/Political Signs

A. Description

A sign without a commercial message that relates to an election or other event.

B. Standards

Within seven days of the election (closing of polls), all signs must be removed.

10.7.8. On Premise Fuel Price Signs

A. Description

Price signs at automobile service stations or other establishments engaged in the retail sales of gasoline or other fuel for automobiles.

B. Standards

One such sign is allowed for each side of a lot fronting on a public street, provided it does not exceed 15 square feet in area. Any such sign shall be affixed to a permitted freestanding identification sign, to a canopy support in the vicinity of the gasoline pumps, or flat-mounted against the wall of a building.

10.7.9. Gasoline Service Pump Signs

A. Description

Signs announcing the location of gasoline pumps at any establishment engaged in the retail sale of gasoline.

B. Standards

Such signs shall be located in the vicinity of the pumps and shall not exceed four square feet in area.

§ 14-156. Injuring fixtures and other property of electric- power companies. It shall be unlawful for any person willfully and wantonly, and without the consent of the owner, to take down, remove, injure, obstruct, displace or destroy any line erected or constructed for the transmission of electrical current, or any poles, towers, wires, conduits, cables, insulators or any support upon which wires or cables may be suspended, or any part of any such line or appurtenances or apparatus connected therewith, or to sever any wire or cable thereof, or in any manner to interrupt the transmission of electrical current over and along any such line, or to take down, remove, injure or destroy any house, shop, building or other structure or machinery connected with or necessary to the use of any line erected or constructed for the transmission of electrical current, or to wantonly or willfully cause injury to any of the property mentioned in this section by means of fire. Any person violating any of the provisions of this section shall be guilty of a Class 2 misdemeanor. (1907, c. 919; C.S., s. 4328; 1993, c. 539, s. 94; 1994, Ex. Sess., c. 24, s. 14(c).)

§ 136-32. Other than official signs prohibited. No unauthorized person shall erect or maintain upon any highway any warning or direction sign, marker, signal or light or imitation of any official sign, marker, signal or light erected under the provisions of G.S. 136-30, except in cases of emergency. No person shall erect or maintain upon any highway any traffic or highway sign or signal bearing thereon any commercial advertising: Provided, nothing in this section shall be construed to prohibit the erection or maintenance of signs, markers, or signals bearing thereon the name of an organization authorized to erect the same by the Department of Transportation or by any local authority referred to in G.S. 136-31. Any person who shall violate any of the provisions of this section shall be guilty of a Class 1 misdemeanor. The Department of Transportation may remove any signs erected without authority. 19A NCAC 02E .0415 ADVERTISING SIGNS WITHIN RIGHT OF WAY

It shall be unlawful for any person, firm or corporation to erect or place any advertising or other sign, except regulation traffic and warning signs approved by the Department of Transportation, on any highway or the right of way thereof, or so as to overhang the right of way, or to permit the erection or placing of any advertising or other sign, as herein prohibited, on any highway right of way which is situated over any land owned, rented, leased or claimed by such person, firm or corporation . It shall be unlawful for any person, firm or other corporation that has erected, or placed, or permitted to be erected or placed , any advertising or other sign, as herein prohibited, or for any person, firm or corporation owning, renting, leasing or claiming any land over which a highway or highway right of way is situated, and on which highway or highway right of way any advertising or other sign has been erected or placed, to allow such advertising or other signs to remain on state highway or right of way thereof.
